Timings:

In case of commercial aircraft, no later than 60 minutes prior to departure from the last port of call.

In case of private aircraft, no later than 60 minutes prior to departure from the last port of call

In the event of any changes to the flight header data or data relating to an individual on board, an updated APIS file submission is required of all passengers/crew on the flight at final closeout prior to departure of the aircraft, for both outbound and inbound flights.
